It has come to our attention that products that infringe Players' rights are being displayed, sold and/or offered for sale on Teespring, <http://teespring.com> (the "Website").

Please note the following:

1. I am authorized to act on behalf of the owner of an exclusive intellectual property right that is infringed, and my signature is provided below.
2. The material identified on the web pages at the links below (the "Material") features the names, nicknames, numbers, likenesses, images and/or other personal indicia of Players, and is unlicensed and not created by or with the consent of the relevant Player, his agent, or anyone here at the MLBPA. This is a violation of MLBPA and Player intellectual property rights, including rights of publicity. The following Material is infringing:

3. I have a good faith belief that the aforementioned listings contains Material that is not authorized by the intellectual property owner, its agent, or the law.
4. I hereby state, under penalty of perjury, that the above information is, to the best of my knowledge, accurate, and that we are authorized to make this complaint on the intellectual property owner's behalf.

With this writing, I ask that Teespring immediately take steps to pull down the aforementioned Material and any other materials that similarly use Players' rights displayed, sold, promoted, or offered on the Website and associated social media sites, and cease all sale, shipment and distribution of such materials.

Please provide contact information for the sellers so that we may send a C&D letter to them.

This email is being sent without prejudice to the rights and remedies at law or equity otherwise available to the MLBPA, its members or agents, all of which are expressly reserved. It does not purport to be a full recitation of the facts related to the subject matter hereof. Thank you,
