

Official Rules for the Acme Packing Company-Gillette Father's Day 2016 Giveaway at Walmart

No Purchase Necessary. A Purchase will not Increase Your Chances of Winning.

- Eligibility:** The Acme Packing Company-Gillette at Walmart Father's Day 2016 Giveaway (the "Giveaway") is open only to legal residents of the United States who are at least eighteen (18) years of age and are registered members of www.acmepackingcompany.com (the "Giveaway Site"). Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, the judges, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter.
- Sponsor:** The Giveaway is sponsored by Vox Media, Inc., 1201 Connecticut Avenue, NW, Washington, DC 20036 ("Sponsor").
- Agreement to Official Rules:** By entering the Giveaway, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor's decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- Entry Period:** The Giveaway begins at 1:00 PM ET on Monday, June 20, 2016 and ends at 12:59 PM ET on Saturday, June 25, 2016. Entries submitted before or after the Entry Period will not be eligible. Sponsor's computer is the official time-keeping device for the Giveaway.

There is a limit of one (1) Entry per person/e-mail address. Additional Entries will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any Entries received through such methods, as determined by Sponsor, in its sole discretion.

If a potential winner does not respond within two (2) business days after the notice is sent, the Sponsor will select an alternate potential winner in his/her place in a random drawing of all remaining Entries who answered all of the trivia questions correctly. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity

release. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining Entries who answered all of the trivia questions correctly. Only three (3) alternate potential winners may be contacted for each Prize Package.
